## School Construction and Maintenance

**Projects 2020-21** 



At Aloma Elementary, a tot lot sunshade was installed in January 2020.

New staircase treads were installed at **Arbor Ridge School**. A tot lot playground shade structure was installed in August 2020.

At **Bonneville Elementary**, a capital renewal project in 2020 and early 2021 will update and improve the heating, ventilation and air conditioning system; the metal roof on Building 3 and the upper roof on the cafeteria will be replaced. All fluorescent light fixtures will be upgraded to LED technology. In addition, new youth and tot lot playgrounds were completed in 2019. The tot lot sunshade was completed in July 2020.

At **Camelot Elementary**, a new youth and tot lot playground was completed in 2019. A tot lot sunshade was installed in 2020. A Curb Appeal project was completed in January 2020.

At **Castle Creek Elementary**, a tot lot sunshade was completed in January 2020. Two chillers were replaced in November 2019. A Curb Appeal project was completed in November 2019.

At **Cheney Elementary**, a tot lot sunshade was installed in July 2020. Replacement of air conditioning chillers is scheduled for 2021.

At **Columbia Elementary**, a tot lot sunshade was installed in July 2020. Two chillers were replaced in August 2019.

A comprehensive renovation of **Corner Lake Middle** was completed for the 2019-20 school year. New accessibility ramps were installed in 2020.

At Cypress Springs Elementary, a new tot lot playground shade was installed in July 2020.

At East Lake Elementary, a tot lot playground shade was installed in January 2020.

At **East River High**, the football scoreboard was replaced in 2019. New security fencing, new baseball and softball field lighting and a new rubberized track are on schedule for completion in 2020. Interior painting campus-wide is scheduled for 2021.

A project at **Glenridge Middle**, including upgrades to LED lighting, improvements to elevator equipment and security systems, new intercom and fire alarm systems and replacements of select heating, ventilation and air conditioning system components will start construction in 2021.



At Lakemont Elementary, replacement of air conditioning chillers is scheduled for 2021.

A capital renewal project completed in January 2020 at **Lawton Chiles Elementary** included improvements to select heating, ventilation and air conditioning system components as well as replacements of window seals, gutters and downspouts. The tot lot playground is being replaced. A shade structure and PE pavilion fans were completed in August 2020. Replacement of air conditioning chillers is scheduled for 2021.

Improvements at **Riverdale Elementary** are underway and scheduled for completion in 2020 will include upgrades to the heating, ventilation and air conditioning system, new window seals, gutters and downspouts and an upgrade of the intrusion detection system. A new youth playground was completed in June 2020. A tot lot playground shade structure was installed in July 2019.

At Union Park Middle, two chillers were replaced in December 2019.

New facilities for field events have been completed at **University High**. The auditorium stage was replaced and a Curb Appeal project was completed in March 2020. New security fencing and new baseball and softball field lighting are on track for completion in 2020. Existing stadium lighting will be replaced in 2021.

At Wedgefield School, a tot lot shade structure was completed in July 2020.

At **Winter Park High** new baseball field lighting was completed in 2019. Improvements to the kitchen cooler and freezer are scheduled for completion in November 2021. Exterior painting campus-wide is scheduled for 2021. The school is also scheduled for a comprehensive renovation that is set to begin design in June 2021 and be completed in February 2026.
