### Minutes

Jim Preusser	Good morning, Wendy. My team is joining.
Wendy Doromal	Ready to read an opening statement. And, we are going to start with Salary?
Jim Preusser	Yes, we have some updates.
Wendy Doromal	See Appendix A.
Jim Preusser	There are two things I would like to accomplish now and discuss with your team. First, teacher salary allocation which we are going to put up on the screen. Judith Padres is here to add comments. Second, I would like to speak to a revised summary of allocated wages, I have had an opportunity to speak with the state about the allocation and so I would like to give an update on that. And then we can go from there.
Wendy Doromal	That sounds good. We need to talk about mental health and evaluations as well.
Jim Preusser	Yes. We would like to talk about that after we discuss wages. We responded to your request for information. There is quite a lot of information there so we would be happy to speak to that.
LeighAnn Blackmore	I need to be able to share the screen.

Lucia Piva	Mark is trying to get on. His link is not working.		
Jim Preusser	We will wait until you are ready.		
LeighAnn Blackmore	This document has been sent to you. It is Exhibit H in response to your RFI. It is an update to the salary allocation following our bargaining session last week.		
	Look at the first section. You will see the allocation, the \$37M. You will see the unweighted FTE for the total. We removed the deduction for growth. There has been a revision to charter unweighted FTE. The original allocation of \$37M was based on a forecast of charter FTE. What we originally presented utilized the budgeted charter FTE. Since the legislature used the forecasted charter FTE, we made that adjustment. That bring the amount available for salary and benefits to \$34.5M. When we subtract benefits, the amount available for salary is \$28.7M. 80% is \$22.9M and 20% is \$5.7M. This is the revised allocation. (See Appendix B)		
Albert Davies	The old number = 7.4207% and the new number is 7.7% for a change of .275%.		
LeighAnn Blackmore	.077 is the charter percentage.		
Albert Davies	Using the new numbers, we are about a quarter percent higher?		
LeighAnn Blackmore	I'd rather not say. I don't have that in front of me. We clarified with the state and this is how the state allocated the money.		
Jim Preusser	Albert, we can look at that when we caucus.		
Albert Davies	I just did the math on it. Rounded it is 7.7%		
Jim Preusser	We understand. Are there any other questions, or do you want to keep going?		
Wendy Doromal	Go ahead		
Jim Preusser	Next document please. If you recall, we had a disagreement about the interpretation of the statute. I reached out to the state and discussed the allocation. Most districts throughout the state cannot get to \$47,500. We can get the full-time classroom teachers to the \$47,500 based on the 80% allocation of the funds. It costs \$20.4M. My discussion with the state was "can you combine the left over from the 80% allocation with the 20% bucket? And can you utilize those funds for both full-time classroom teachers who received less than 2% as well as any other any other full-time instructional staff with the remaining funds?" The answer is yes you can do that. It is not common throughout the state. What you have is \$2.5M. Prior to today is was \$2.3M and that is what LeighAnn just walked you through. When you take the \$2.5M and combine with the 20% you are at \$8.2M. The clarification that I did get from the state and I think you had some of this imbedded in our proposal, if you are suggesting to provide an increase to the full-time classroom teachers who have received a 2% raise or more, you can't give any more money for raises. That would be a violation of the statute. The rest are fair game. It is for classroom and non-classroom teachers that didn't get to a 2% increase. I am going to stop there and see if you have questions. (no questions) So tell us how you want to spend the \$8.2M. I am sure you will caucus. I'm not asking you to answer that now. (See Appendix C)		
Wendy Doromal	We are going to caucus and see if we can conform the proposal to meet the statute.		

Jim Preusser	My comp team are on the call and they can help. Do you want to pause now and caucus, or keep going?
Lucia Piva	Maybe we should caucus because Mark is having trouble getting on.
Jim Preusser	We will email you the second document and I emailed the conversation with the state. What time should we come back?
Lucia Piva	Maybe 30 minutes?
Wendy Doromal	Yes, and we can form questions.
Jim Preusser	We will wait for your questions and hopefully we can answer them. When we come back we will go through the RFI.
Wendy Doromal	All of the RFI questions were self-explanatory except #2.
Jim Preusser	We will have Stephanie speak to that when we get back. Come back at 1:00?
Wendy Doromal	Yes that is good.
	CAUCUS (From 12:22 PM to 1:08 PM)
Jim Preusser	We are ready to go when you are.
Albert Davies	We see a lot of variance in the budget. There are places where you can find more money.
Jim Preusser	We spoke to that in our RFI. The response was prepared by Doreen.
Albert Davies	I did read that, but that's not the point we brought up before. Every single year expenses are projected higher than they end up being and tax revenues lower and it shows the continual amount of money that is left every single year and it is hard for us to believe that some of those line items could not have been made tighter.
Jim Preusser	I can understand your position. I think that Doreen has addressed that. Doreen is not here and we can get into more specific detail later.
Wendy Doromal	I think that what we should do is to review numbers more, and take a little more time to see how we can shift funds.
Jim Preusser	You are talking about the 8.2M?
Wendy Doromal	That and making sure everyone is at \$47,500 and look at the balance and any other suggestions.
Jim Preusser	Do you want us to look at your suggestions?
Wendy Doromal	I think we need more time to look at this and to make a decision
Jim Preusser	For example, you spoke in your opening statement about classroom and non-classroom, I think I heard you say to get those below \$47,500 to it. There are 612 teachers below \$47,500 if we raised them to \$47,500 we can tell you the cost of that. It would come out of that \$8.2M.
Wendy Doromal	That would be good. And can you give us any updated lists? I think our numbers are wrong because we have around 500 teachers below \$47,500.
Albert Davies	The report that was run as of 8/14 was 595 non-classroom not at \$47,500. Our employee list has 14,236 teachers

Jim Preusser	Elizabeth, can you share the numbers?
Elizabeth Silva	We are still using the 8/14 data and it is 612 employees that are below the \$47,500.
Jim Preusser	If we were to move the 612 non-classroom to \$47,500, what would that cost?
Elizabeth Silva	\$1,920,350.
Jim Preusser	We can send that to you so you have it. That number would come out of the \$8.2M.
Elizabeth Silva	That would leave \$6M.
Albert Davies	We need the breakdown of the teachers. The list you gave us was 14,236 teachers. Our breakdown doesn't match your numbers. 11,884 classroom teachers of which 5,429 are below \$47,500; 2,029 other non-classroom teachers of which 595 are below; and 109 Pre-K teachers of which 38 are below. And 114 school psychologists.
LeighAnn Blackmore	We cannot fund Pre-K teachers. They are not funded through the FEFP.
Wendy Doromal	Yes they are.
LeighAnn Blackmore	They are specifically excluded from the law.
Wendy Doromal	That is not the information we got from FEA.
Albert Davies	Might be a definition difference then because the statute specifically talked about Pre-K teachers also.
LeighAnn Blackmore	It is Pre-K teachers that are not funded by FEFP. There are 109 Pre-K teachers. I don't mean Pre-K ESE that are funded by FEFP.
Jim Preusser	Yes, there is a bifurcation between the two.
Wendy Doromal	Send us your information that would help.
Jim Preusser	I will have Theresa and Elizabeth send you a summary of the numbers of teachers. We will show you the cost for the non-classroom teachers to send them to \$47,500. And then show you the remaining dollars to work with.
Albert Davies	You are talking about non-classroom, we want to see all the non-classroom including the school psychologists and the Pre-K teachers
Jim Preusser	Elizabeth, are you good with that?
Elizabeth Silva	Yes.
Wendy Doromal	We also want a list of teachers paid by a grant or partially paid by a grant and how many there are.
LeighAnn Blackmore	We provided what was asked for which was
Albert Davies	We got the numbers but we didn't get the list.
LeighAnn Blackmore	They are still included as part of the teachers who will be paid out of the allocation.  They can't be excluded in the calculation.
Albert Davies	You are saying that the state gave us money but part of these teachers have to have raises and are not paid out of state money, so wouldn't those teachers be excluded from the cost?

LeighAnn Blackmore	No, it speaks to full-time classroom teachers, it doesn't differentiate on full-time classroom teachers, grant funded or not. The grant funds won't pay the extra money for the raises. I can resend you the information.
Wendy Doromal	And tell us the amount of money you are saving in grant funded teachers.
LeighAnn Blackmore	Send me the question so I can answer correctly.
Jim Preusser	Please summarize your questions in an email so we won't miss anything. Elizabeth can get you the list of teachers later today or tomorrow. With respect to the other questions about grants, tell us what we are missing with the information and LeighAnn will send it to you.
Lucia Piva	We need time to continue this conversation once we have received all the information and have time to process it.
Jim Preusser	Sure, do you want to confirm a bargaining date?
Lucia Piva	Wendy, do you have your calendar?
Jim Preusser	How about October 8?
Lucia Piva	That works for me and Mark, how about you Wendy?
Wendy Doromal	Yes.
Jim Preusser	We can start at 10 AM and go to 4 PM.
Albert Davies	Let's make sure that the notices get sent to principals and bargaining members. Mine didn't get one today again.
Wendy Doromal	Our members are not being copied.
Jim Preusser	Ok, LeighAnn and I will touch bases with Donna on that. We will stop with the discussion on wages for now unless anyone has any more questions.
Wendy Doromal	No, I don't think anyone has any more questions.
Lucia Piva	We have two more issues, Evaluation and Mental Health. We have a counter on Mental Health and will forward to you. On evaluation, we need more time to talk about it. We have some of your questions to answer and we will get them to you.
Jim Preusser	You have a counter on Mental Health to what we countered? Mary Bridges is on and please ask questions of her. Additionally, I have Stephanie here for Evaluation questions. Thanks for recognizing the information that you owe to us. We will wait to hear from you. The RFI answered your Evaluation questions on statutory violations. We can certainly have more discussion on that.
Wendy Doromal	We will speak to that after the Mental Health counter.

Lucia Piva	#1: no change

Jim Preusser	Mary, any questions or do you want to review it off line?	
Mary Bridges	No questions.	
Jim Preusser	We will review in caucus we may have some additional questions. Thank you. Now I would like to pull up the RFI and talk about #2. Stephanie will talk to it. And she can speak to #3 because you all asked who we consulted with about evaluation in other districts. (See Appendix E)	
Wendy Doromal	Maybe review these real quickly.	
Jim Preusser	LeighAnn and I will speak to #1.	
Wendy Doromal	Although I was promised to have access to intranet, I still don't have it. So anything that you send us with a link is useless to CTA. We will have to have the documents.	
Jim Preusser	Let me speak to our CIO about that.	

### Stephanie Wyka

#2. High level: specific provisions presented by you last week presented some overall challenges with the statute that requires the district to differentiate with 4 performance levels within their calculation processes.

F.S. 1012.34(2)(e) identifies that a district's performance evaluation system must differentiate among four performance levels - Highly Effective, Effective, Needs Improvement/Developing, or Unsatisfactory. By stating that all teachers shall receive at least an effective rating, the provisions proposed by CTA do not comply with F.S. 1012.34. Furthermore, the CTA provision stating that all teachers shall receive at least an effective does not comply with F.S. 1012.34 (3)(a)1. and its requirement to base one-third of a teacher's performance evaluation on growth and achievement data of the teacher's students. The Commissioner of Education has not waived compliance with F.S. 1012.34 in the 2020-2021 school year like he did in the 2019-2020 school year. F.A.C 6A-5.030 establishes the requirements for the annual evaluation of instructional personnel. The provisions provided by CTA would prevent the district from adhering to several key components of this administrative code. In order for an evaluation system to be approved, F.A.C 6A-5.030(3)(c)1.b., F.A.C 6A-5.030(3)(c)2.b., and F.A.C 6A-5.030(3)(c)5.c. require that district's provide a description of the step-by-step calculation for determining the student performance, instructional practice, and summative evaluation ratings including performance standards for differentiating performance. CTA's provision requiring all teachers to receive at least an effective rating would not comply with the administrative code components, especially the necessity to differentiate

F.S. 1012.34 and F.A.C 6A-5.030 both address components related to district required personnel and Department of Education notifications of unsatisfactory performance in these subsections: F.S.1012.34(4), F.A.C 6A-5.030(3)(d)1.f., and F.A.C 6A-5.030(3)(d)1.g. The CTA provision stating that all teachers will receive at least an effective evaluation would not comply with these statutorily required functions.

performance as required in F.S.1012.34. \*\*\*\*

Finally, FS.1012.34 and F.A.C 6A-5.030 require the use of evaluation data to identify individual professional development and the use of evaluation data to inform school and district improvement plans in these subsections: F.S.1012.34(2)(a), F.S.1012.34(2)(b), F.A.C 6A-5.030(3)(d)1.h.(V), and F.A.C 6A-5.030(3)(d)1.h.(VI). The CTA provisions related to only counting an evaluation toward summative score upon mutual agreement and requiring all teachers receiving at least an effective rating prevents the district from ensuring adherence with the statutory requirements identified as the data would not comply with F.S.1012.34 and F.A.C 6A-5.030. This then would prevent the district from successfully identifying professional development needs and priorities for school and district improvement plans according to evaluation data.

Jim Preusser

Any questions?

Maribel Rigsby	I understand the statute, but there are things we are able to do to meet the requirement. We do have 4 domains and we do have our elements. Everything is documented. The District has ways to say how it can be implemented. I understand the statute, but there are still some things we can do.  We still have not addressed how we will do hybrid models. The District is doing a social and emotional learning component, how will it impact evaluation? We need to put something together that makes sense for this year. Our evaluation system doesn't target how to teach during a pandemic. How will LaunchED work? We need the time to gather information on how it will affect the teachers. What about safety for testing? How will students test from home? How can that be verified and fair?
Wendy Doromal	In our contract it says audio visual monitoring for the purpose of evaluation shall not be permitted however electronic for informal observations shall be permitted with a signed agreement. It is not even permitted for formal according to our Contract.
Ladera Royal	I don't not see how what we proposed would not fit the statute. We are not asking you to change your categories within your procedure or in your evaluation assessment. We are not asking you to change, just that certain ones not be used. Ensure that student growth is fair with the testing. Evaluations have to be valid and criterion must hold merit. The playing field must be the same for everyone. How can we assure that will happen?
Stephanie Wyka	I would like to clarify one thing. The specific question that was asked of us was that what statutory violations referenced in the CTA Evaluation MOU with explanation. Clarifying that, this is what we provided because the statement "all teachers no lower than effective" doesn't allow us to adhere to the statute. To Ladera's point on demonstrating the calculation, we are required to utilize that calculation. Then the DOE approves it. Any change must be resubmited to the state. From our analysis, that provision would not meet the requirement. Maribel stated that there is an understanding of what we shared and why it would not comply. Is that what I understood? I appreciate that we need some more discussion on the different delivery models.
Wendy Doromal	We will continue to look at the statute and look at other districts hold harmless clauses.
Stephanie Wyka	#3. Other districts. I reached out to three that are similar in size. Broward, Hillsborough and Palm Beach. None of them has official signed contract language. What was indicated by Broward and Hillsborough was deferring timelines to acclimate to the new normal and reduce frequencies. Palm Beach not planning to make changes but could be changed in the future.
Wendy Doromal	Thank you, Stephanie.
Jim Preusser	With that being said, there is more information in here, you all can review and ask additional questions. At this point we can confirm October 8 from 10 to 4.
Lucia Piva	You will get back today on the Mental Health counter?

Jim Preusser	We want to caucus. If I can get you a response I will and I will work with the compensation team on the information you need.
Wendy Doromal	Questions: other topics. The minutes are not reviewed by whole team. It gives the impression to the public that these are the "Official minutes". I think there should be a disclaimer that the minutes provided by the District and have links to the other team's minutes.
Jim Preusser	Actually, Wendy, it does say that.
LeighAnn Blackmore	I can read it to you. Beginning in 2019-20, the District and CTA no longer approve joint minutes from bargaining meetings. Each party prepares and posts minutes on their respective websites. The District maintains its minutes here. You may find CTA minutes at <a href="http://orangecta.fea.aft.org/bargaining-meeting-minutes">http://orangecta.fea.aft.org/bargaining-meeting-minutes</a> .
Wendy Doromal	Thank you, LeighAnn, I didn't see that, I just heard that the minutes were wrong. The District's COVID dashboard is not updated as it said it would be daily. Some things are missing. We know people personally that tested positive that are not on the dashboard. Some people who tested positive who have a letter from the Department of Health are not on their website. What is going on? We wanted to have some clarity there. I asked you LeighAnn to give me the information that was missing, you did not answer my questions. There are columns but there's no numbers in some and information is missing.
LeighAnn Blackmore	I did answer your questions.
Wendy Doromal	I think you misunderstood my questions. I will send the information on this request specifically. I will try to ask in a better way. I think we are talking about two different things.
LeighAnn Blackmore	I have some information on the COVID-19 dashboard. There was a glitch on Monday. It was a technical glitch with Microsoft 360. The data is current through September 29.
Wendy Doromal	Actually, there are mistakes in what was put up last night. In one place it says there are 5 cases reported and actually there were 6. The numbers are incorrect.
Jim Preusser	Which school is missing?
Wendy Doromal	I will send it to you.
Jim Preusser	We will look at it. Bargaining on October 8? We will need a public link. I will follow up with Donna about the releases.
LeighAnn Blackmore	I will send you our team plus others.
Wendy Doromal	Please give me the additional people
Jim Preusser	Thanks for your time today. We will get information to you ASAP.

## Appendix A



### September 30, 2020 CBLT Meeting

### Statement of President Doromal

#### Good Afternoon.

Last week Governor DeSantis moved the state to Stage 3, reopening all restaurants and businesses to full capacity. Medical experts and scientists have called his move dangerous. Dr. Fauci said that the move was "very concerning and will lead to more coronavirus outbreaks." John Hopkins University stated that Florida residents are testing positive at a rate of more than 10%, although the state's Department of Health reports a positivity rate of lower than 4%. We cannot trust our leaders to protect students, employees and their families. Throughout this crisis our local, state and national leaders have demonstrated that financial profits trump the health and safety of students, employees and community members.

OCCTA demands to bargain any changes related to working conditions and workplace safety that OCPS is considering because of the governor's reckless and dangerous Stage 3 order. We are alarmed by the District's constant unilateral changes to plans, policies and procedures that impact teachers' working conditions. The District's COVID-19 Health and Procedures Manual made and changed continually, without union input, is already on version 8.0.

As we sit down today to discuss raises and evaluation procedures for this school year, we must remember that the only thing that is certain about this school year is the uncertainty. Teachers have been asked to make the impossible possible, the unworkable workable and to infuse hope into a sometimes hopeless situation to ensure student success. They have gone above and beyond to adapt to autocratic mandates and unreasonable expectations that the District has heaped upon them. These include teaching face-to-face and virtual students simultaneously, which may be a convenience for the District, but is certainly a worst practice that serves neither the students nor the teachers. These include expecting teachers to work many hours past their 7.5-hour work day contacting parents, creating innovative lessons and responding to administrators who do not respect their evenings or weekends as time off the clock. These include being asked to have large class sizes and welcome new students continually, even though social distancing cannot be observed. These include being expected to teach face-to-face students without showing fear, even though teachers have approved ADA accommodations and were advised by their physicians not to return to their school buildings to protect their health and lives.

The raises given to every member of our bargaining unit should reflect the challenges, extra work and commitment that has been demonstrated throughout this crisis. Veteran teachers cannot be written off in salary negotiations. They are the ones mentoring the new teachers, picking up the slack in their schools, serving as school leaders, and they are the ones who have demonstrated years of loyalty and dedication to OCPS.

The District must examine the elitist system that rewards administrators and regards educators as replaceable, disposable labor units. Any District that spends over 4 million dollars to give an elite group of over 200 administrators a 25.41% retirement plan must acknowledge the inequities in spending and the divisive climate it has created. The disparities between how administrators and teachers are treated can also be witnessed when violations of district policies are committed. Teachers are hauled down to Professional Standards on trivial policy breaches, while administrators are not even noticed when they violate policy. During the last bargaining meeting, a district CBLT member was heard swearing. One would expect that a public apology is in order.

Again, let me say the only certainty about this year is the uncertainty. What evaluating administrator has taught virtually or has taught a so-called blended model? What administrator has had to deal with internet connection problems, parents jumping in and out of the classes, and the other problems teachers have masterfully handled this school year? Every single educator must be innovative to perform under these unstable and challenging conditions. How can teachers be fairly evaluated when they are overworked, overstressed and must adapt in the moment every day to deal with quarantines, and ever changing circumstances? Conditions and fairness must be considered when deciding the evaluation process and raises this year.

# MEMORANDUM OF UNDERSTANDING BETWEEN THE SCHOOL BOARD OF ORANGE COUNTY, FLORIDA AND THE ORANGE COUNTY CLASSROOM TEACHERS ASSOCIATION

This Memorandum of Understanding is made on this \_\_\_\_day of May September 2020, by and between the School Board of Orange County, Florida (District) and the Orange County Classroom Teachers Association (OCCTA).

#### **PURPOSE**:

The purpose of this Memorandum of Understanding is to clarify the roles of Instructional Personnel\* as they relate to Rule 6A-1.094121 Mental and Emotional Health Education.

WHEREAS, Rule 6A-1.094121 establishes Mental and Emotional Health Education for grades 6-12.

### WHEREAS, Rule 6A-1.094121 provides that:

"School districts must annually provide a minimum of five (5) hours of instruction to students in grades 6-12 related to youth mental health awareness and assistance, including suicide prevention and the impacts of substance abuse."

### **WHEREAS**, Rule 6A-1.094121 also provides that:

- "By December 1 of each year, each school district must submit an implementation plan to the commissioner at MentalHealthEducation@fldoe.org and post the plan on the school district website. The implementation plan must include:
- (a) The specific courses in which instruction will be delivered for each grade level;
- (b) The professional qualifications of the person delivering instruction; and
- (c) A description of the materials and resources utilized to deliver instruction."

### WHEREAS, the parties entered into a Letter of Understanding on February 27, 2020 that provides:

<u>Instructional personnel teaching Mental Health Curriculum shall not be observed for evaluation</u> purposes during Mental Health course instruction. The five-hour course will not be used for the

To offset the time required to be spent in preparation for Mental and Emotional Health instruction, teachers who deliver the session will be released—with students on one early release day for each day they deliver a session. - 5. <u>Instructional personnel used as facilitators for the course will not be evaluated during Mental Health</u> course instruction.
- 6. The five-hour course will not be used for the calculation of the Student Learning Growth.

Principals today told teachers their budgets were cut so they had to release teachers. We were told that Tallahassee stated no budget cuts were being made this Fall. Who cut school budgets?

Districts were told FTE funding would be held harmless until the end of the emergency order, which is December 31st, or the end of the first semester. The district performed the school recalculation exercise based on actual warm body count in order to determine the extent of over allocating or over funding across the district. Schools were asked to identify the number of positions that would have been impacted, yet there were no reductions at this time. In some instances schools are experiencing growth, and OCVS has seen a large increase in enrollment. Instructional resources need to shift in order to meet the needs at other locations. Volunteers were requested from schools that are overstaffed.
