McKinney-Vento Corner

The McKinney-Vento Act provides students experiencing homelessness with the right to:

- Immediate
 Enrollment (even
 without normally
 required documents)
- 2. Free Lunch
- Continue at the school they attended before becoming homeless or the last school attended, if in their best interest.
- 4. Request transportation to remain at the same school
- 5. Have enrollment disputes heard and resolved while the student attends class
